



Treatment and Appliances NOT COVERED

- Treatment and surgery for cosmetic purposes \geq
- \geq Non-conventional medical treatment or procedures except those treatment that are available at Government Hospital
- ≻ Unproven alternative therapies
- Routine health check-ups unless prescribed by physician of \geq University Clinic or approved by University.
- Appliances like spectacles, contact lenses, dentures and \geq disposable items.
- LASIK treatment \geq
- ≻ Dental treatment outside the University Clinic
- Any family planning procedures ≻
- Specialist treatment for minor condition which does not \geq endanger patients life such as skin diseases, pimples etc.
- ۶ Health diet/Supplements
- ≻ Injury or diseases obtained as a result of intentional act that endanger one such as drug abuse and alcohol consumption and any other immoral activities.
- Any staff who is going abroad, may make arrangement on his ≻ own health insurance coverage during the period. Any treatment received by the staff or eligible dependants outside the country is not reimbursable. However, if the staff is on official duty as defined, all emergency medical expenses will be covered by the University for an acute illness where treatment cannot wait till his return to Malavsia.





For pre-existing medical conditions which are chronic and/or complicated, the University will not cover any medical expenses for the <u>first twelve (12) months</u> of his / her employment in IIUM. This also applies to the staff's spouse and dependents.

Ward Eligibility

The rates payable by the staff members admitted in the government/university hospital are as follows: -

GROUP / GRADE	WARD ENTITLEMENT	ELIGIBILITY
45 and Above	1st Class Single Bedroom	RM80
31 – 44	1st Class Two Bedroom	RM60
21 – 30	1st Class Three Bedroom	RM40
1 – 20	2 nd Class	RM40

Maternity Package

Each staff is eligible for only 5 maternity packages during tenure of service with the IIUM
